AUSTRALIAN COURT RULING PROHIBITS THE COLLECTING OF BAYONETS

A South Australia Court Appeal Judgement Throws Doubt on Authority to Collect Bayonets

An Australian man has been convicted of owning two bayonets and two K Bar knives, the court refusing to accept his defence that he was a collector of WW I & WW II memorabilia because he had no positive authorisation in law. Now SA Police appear to be telling Gun Show organisers not to allow bayonets to be sold. One wonders how many Ausies have a bayonet or two as family heirlooms or simple decorations.

This judgement raises a number of questions:

How many bayonets constitute a collection, recognizing that any collection has to start with one item?

How many items do you have to collect before you need to catalogue them?

Could the same thing happen in New Zealand?

Bearing in mind that this has come about more by default than intent, it illustrates clearly why all collectors need to remain vigilant to defend our ability to collect what we choose. We can do that best by being part of a strong and active organization with a world-wide network of like minded collectors.



Here we have two examples of the No 4 Mk III bayonet; (BCB B 269) these bayonets were developed by J Lucas Ltd in 1942 and were approved for production in February 1943 being announced in the List of Changes C 2425. Time to produce this bayonet with a fabricated socket was considerably shorter and cheaper than the Mk II and II* and J Lucas was contracted to produce 200,000, although the spikes and catches were made by a number of sub-contractors.



The point of interest here is that the spike of the lower bayonet is believed to have been made originally for the Sten SMG Mk I bayonet (BCB B 275), denoted by the 1 about one inch from the socket (above left). Mk III spikes are normally marked close to the socket as the “S” in the RH picture above.

Production of Sten Mk I bayonets amounted to 75,800 and most were destroyed after the war, it is believed that the spikes used in the No4 Mk III bayonet were production over-run.

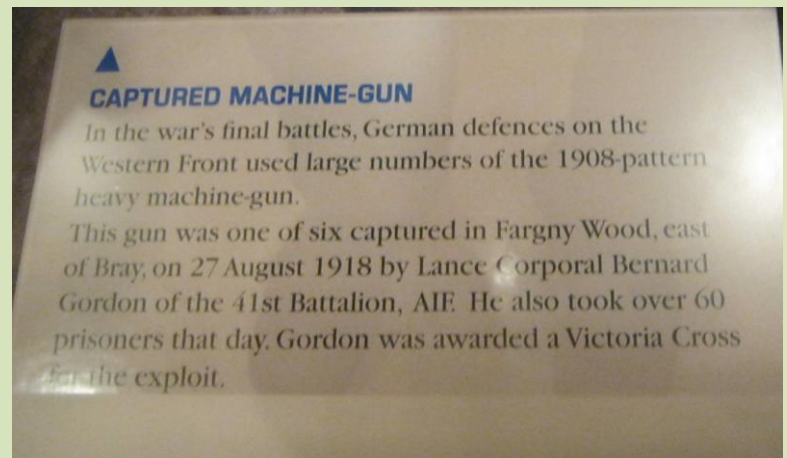

1917 NZ's 'blackest day' at Passchendaele

In terms of lives lost on a single day, this was the greatest disaster in New Zealand's history. The tragic events of 12 October 1917 would leave more than 2700 New Zealanders dead, wounded or missing. Ever since, Passchendaele has been a byword for the horror of the Great War.



Eight days earlier, on 4 October, 320 New Zealanders had been killed during the capture of Gravenstafel Spur, one of two spurs on the ridge above Passchendaele in Flanders, Belgium. Although this attack was successful, it had a tragic aftermath. The British High Command mistakenly concluded that the number of German casualties meant enemy resistance was faltering and resolved to make another push immediately. An attack on 9 October by British and Australian troops was to open the way for II ANZAC Corps to capture Passchendaele on the 12th. The plan failed at the first hurdle. Without proper preparation and in the face of strong German resistance, the 9 October attack collapsed with heavy casualties.

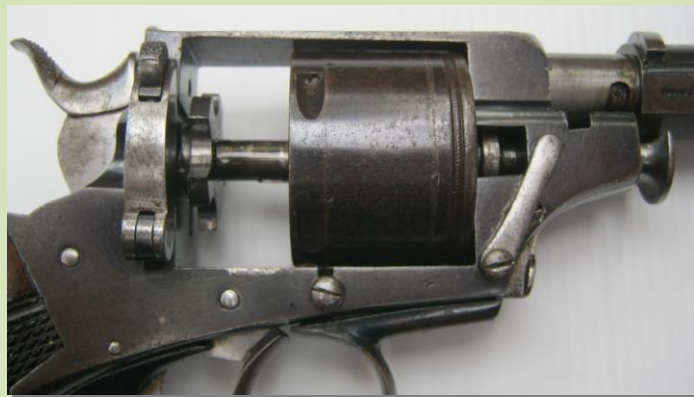
The New Zealanders nevertheless began their advance at 5.25 a.m. on 12 October. The preliminary artillery barrage had been largely ineffective because of the near-impossibility of bringing the guns forward through the quagmire, or stabilising those that were in position. Exposed to raking German machine-gun fire from both the front and the flank, and unable to get through barbed wire that had not been cut, the New Zealanders were pinned down in shell craters. Orders for another push at 3 p.m. were postponed and then cancelled. The troops eventually fell back to positions close to their start line. For badly wounded soldiers lying in the mud, the aftermath of the battle was a private hell; many died before they could be rescued. The toll was horrendous: 45 officers and 800 men were either dead or lying mortally wounded between the lines.

On 18 October, II Anzac Corps was relieved by Canadian troops. In a series of well-prepared but costly attacks in atrocious conditions, they finally occupied the ruins of Passchendaele village on 6 November. The offensive had long since failed in its strategic purpose and the capture of Passchendaele no longer represented any significant gain.

This month I review a **Thomas Patent Self Extracting Revolver**. This revolver employs a novel way of extracting the empty cartridge cases and was patented No 779 by J Thomas a Birmingham gun maker in 1869.



This double action revolver has a 0.38 calibre cast steel octagonal barrel, solid frame with a larger than normal aperture for the cylinder, and a one piece chequered walnut butt. The 5 chamber cylinder is plain with locking notches around the rear circumference. On the left hand side is a screw in hammer lock safety and on the right side a conventional spring latched loading gate.



The unique feature of this gun is the method of ejecting the empty cases. A small catch at the front of the frame is pressed in and this releases the barrel which is then rotated through half a turn and pulled forward. This in turn pulls the cylinder to the front of the aperture leaving the empty cases held in the star shaped extractor on the central spindle; a flick of the wrist should throw the cases clear. The knob on the underside of the barrel aids rotation and a slightly angled flange on the barrel working in a slot in the frame provides a powerful cam action to release even the tightest cases.

These revolvers were manufactured by Tipping & Lawden, where Thomas worked as foreman, until 1877 when the firm was taken over by P Webley & Son. Only about 1,500 were made in various calibres and so they are now quite scarce.



Dear Members,



The focus of this bi-monthly column is to follow on from the lobbying we have undertaken on behalf of firearm owners and to ask you to approach your local member of parliament to introduce yourself as a responsible voter in their community.

As reported in the last column, the Council has been lobbying members of parliament with updated research in regard to firearms in New Zealand and similar societies. This has been in the form of one email per month for the last six months. If you are interested in the emails these are available in the news section of the COLFO website. www.colfo.org.nz

We have also provided a guide for firearm owners to use in approaching their local member of parliament. We ask that you send them an email or arrange to meet them personally. The point of this meeting or email could be to introduce yourself as part of their community, to put a face to a responsible licensed firearms owner that just wants to enjoy their interest in a safe and considerate way.

We have received confirmation from the police that they have completed their review of procedures for the applying for a permit to import a restricted firearm for "Special reasons".

This affects categories B, C, D and E endorsed licensed firearm owners. Section 18.2. of the Arms Act states "...shall be granted otherwise than by the Commissioner who shall first be satisfied that there are special reasons why the pistol, military style semi-automatic firearm, or restricted weapon or parts to which the application relates should be allowed into New Zealand."

The Council asked police national headquarters how this process works between types of firearms and what guidance material was available to arms officers to assist them in applying the process consistently across the districts. As a result of this, the police engaged in a process that took just over a year and has resulted in them circulating a guidance document to all arms officers to ensure the process is consistently applied across the country.

The police operations executive also reviewed the policy as it applies to the various classes of firearms and has agreed to allow MSSAs to be imported, without surrender, by sporting shooters who wish to compete in national competitions. This is significant and aligns to their policy regarding competitive pistol and MSSA shooting.

We recommend you carefully consider the requirements for a successful application to import. If you wish to import a firearm for the purpose of hunting, competition shooting and/or collecting, state it in your application. The reasons do not have to be exclusive, but they do have to be for recognised legal purposes. If your application states a single reason then police may require you to sell or dispose of the firearm when it is no longer required for the purpose you specified. Please consider carefully how you follow the guidance to ensure you understand the process.

For some years COLFO has been involved in reviewing a series of international standards that the United Nations (UN) is proposing for national arms controls. These include the rights and privileges of civilian firearms owners, the storage of firearms and ammunition as well as the transfer of firearms nationally and internationally.

This is the most comprehensive work undertaken to date by the UN on arms control. It could have a large impact on civilian firearms manufacture and ownership.

The Council sent a representative to attend the Conference of the Program of Action in New York, from the 27th August 2012. We were supported as part of the official New Zealand delegation at the UN. While the conference was for two weeks we attended for the first week to keep costs down. The program is intended to control the transfer of illicit small arms, however the agreement between 193 countries is potentially of concern as it does not recognise legal civilian ownership of firearms.

Our attending was to achieve a number of goals:

- First, with the assistance of New Zealand mission staff a CD on how successful New Zealand firearms legislation has been was placed before each delegate. This CD is based on recent research compiled by Chaz Forsyth, who we are indebted to for the dedication and generosity he has shown COLFO over a number of years;
- Second, we met with delegates from various countries and agencies to pass on that New Zealand is in a unique position with both a very safe society and a wide range of firearm user privileges that we can show how civilian firearm ownership can be successful;
- Last, to discuss with the diplomat responsible for negotiating the NZ position how we can have civilian ownership recognized.

PHOTOGRAPHY OF LICENCE HOLDERS SECURITY

Recently an issue was raised concerning the photography of private individual's security measures, locks, safes, buildings etc during security audits by Police, it has been reported that this was being done without consultation or consent. This has caused considerable concern for those involved and as a result COLFO made an approach to Police National Headquarters to clarify the situation.

It is believed that it may have been a local issue in one region only and after due consideration all districts have been advised by Police National Headquarters to cease the practice of taking photographic records of security as part of their audit process.

This query was sorted in less than 24 hours with a directive being issued to all Police Districts. It is a real credit to both COLFO and Police National Headquarters that it was looked at and dealt with so quickly and efficiently and demonstrates the excellent working relationship between the parties.

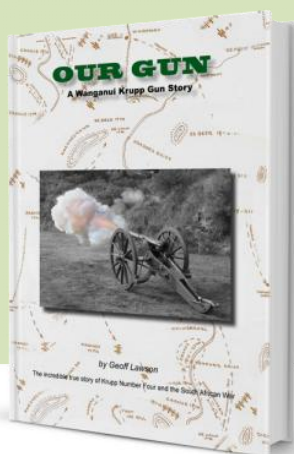

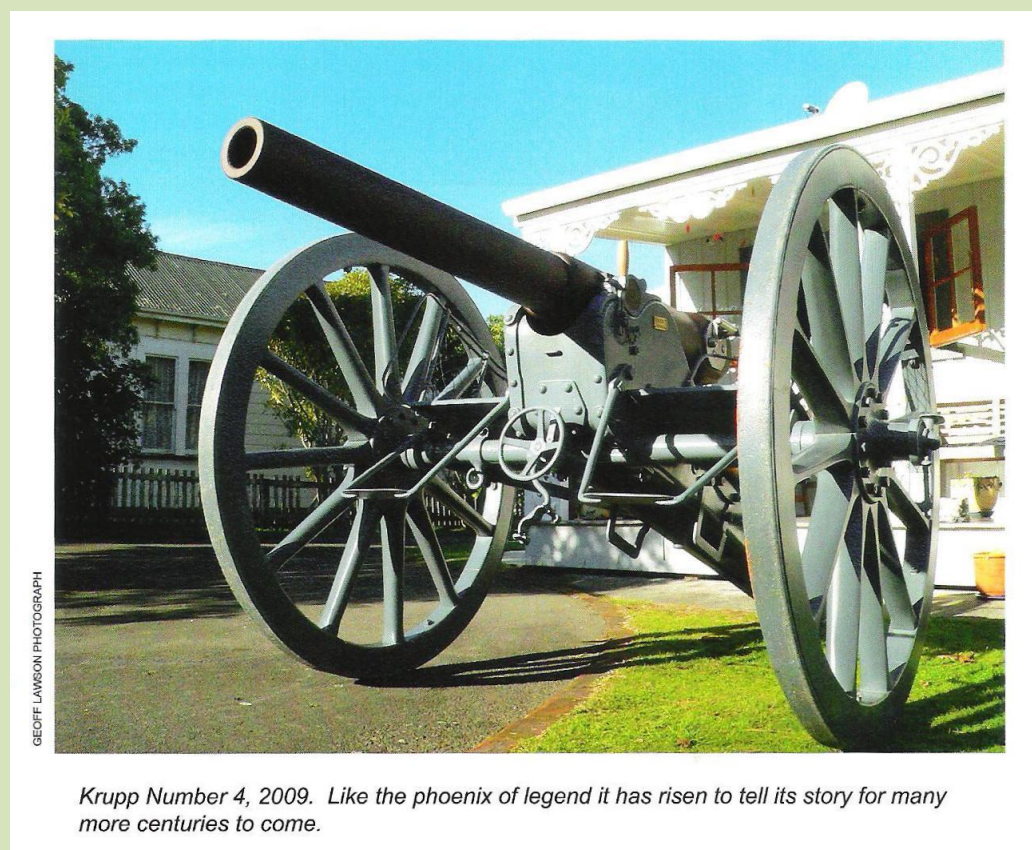
OUR GUN by Geoff Lawson



I found this book a fascinating story, and I am sure it will be of value to anyone with an interest in the Boer War or New Zealand trophy guns. It describes how Krupp Gun Number 4 came to be captured in the Anglo Boer War of 1899-1902 and found its way to Wanganui, where it has recently been restored and now resides in the Wanganui War Memorial Hall on Watt St, open 8.30 - 4.30 Mon to Friday.

This well researched book provides an insight into how the gun came to South Africa, then the reasons why the Boer War came about. The author provides a detailed narrative of the actions that this Boer gun was engaged

in, which lead to its capture on 27 February 1900. He describes how the gun was presented to the New Zealand 4th & 5th Contingents in recognition of their service in the field and returned to New Zealand where it was finally presented to the town of Wanganui. The story concludes with an account of the gun's restoration which commenced in 2006. Technical specifications of the gun and significant dates in its history are given at the back of the book. Having read the book I now want to go and see the gun for myself.

For 80 years a WW1 death plaque, or Dead Man's Penny, has been held by my family and one by my husband's family, along with the original photos, memorial scrolls, letters from the King, and War Records.

10 years ago, the two plaques only, were stolen in a house burglary in the Manawatu, and the Police were unable to locate the offenders, or these two treasured items.

I have no interest in this matter now, no questions or police interest at all. I just want to be able to pass these valued items to my family.

I realise that privacy laws cover sellers and buyers at Auction and sales, but wonder if there is any way the following information, and my contact details can be made available to collectors via Newsletters or Club magazines.

The plaque for my great uncle sold in August last year at an auction in Sydney, and I only found out last week by chance. If only I had known before the Auction! But it may have come back to Dunedin or Otago.

3rd Pioneer Battalion, No 1801/A

41st Infantry Battalion

Served France.

Injured vicinity of Armentieres, died 1/5/1917.

Buried Trois Arbres Cemetery, Steenwerck, near Bailleul.

I would love to be able to get these two plaques back for our son, and ask if there is any way to make the above details, and my contact details known.

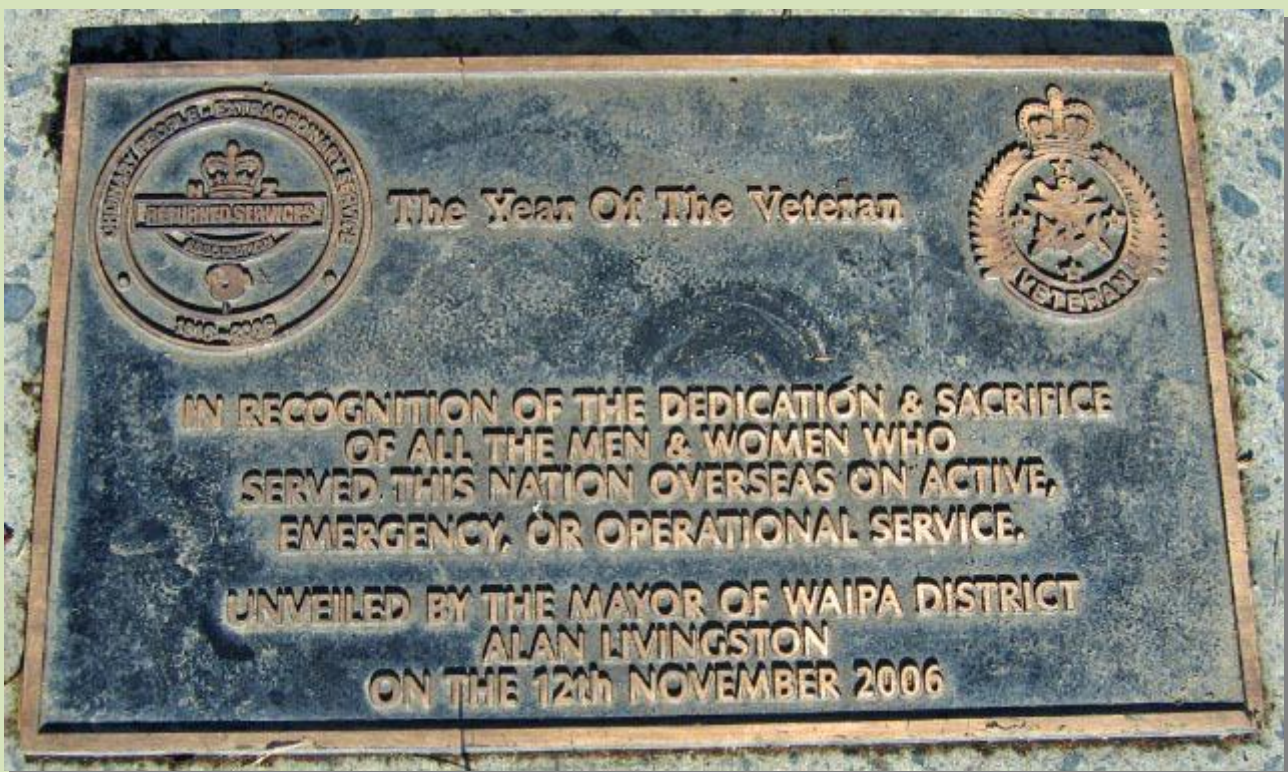

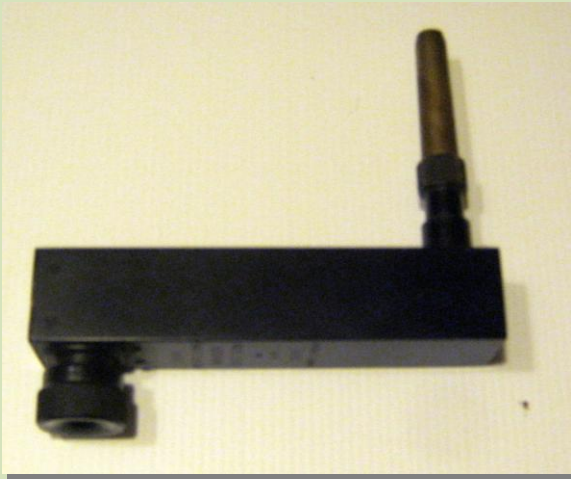
Pattern: 6 pdr MKIII 7 cwt QF Anti-tank Gun. Introduced: 1942. Withdrawn: c1960s
Cambridge Memorial to all men and women who served NZ overseas, contributed by John Osborne.

Located in front of the Town Hall at the junction of Lake and Victoria Streets, Cambridge.



New Zealand's primary anti-tank gun from the middle of WWII until the 1960s. It was first used in North Africa in April 1942, and quickly replaced the 2 pounder in the anti-tank role, allowing the 25 pounder to revert to its intended artillery role. Weight 1,140 kg / 2,520 lb, Barrel Length 2.45m, Gun crew 6, Cartridge 57×441 mm R, Calibre 2.24 in (57 mm), Breech Vertical Block, Split trail carriage, Max Elevation 15 degrees, Max Traverse 90 degrees, Max Range 5000yards, 4600 meters. Muzzle Velocity 2700 Feet Per Second. Effective range against tanks 800 yards. The United States Army also adopted the 6 Pdr as their primary anti-tank gun under the designation 57 mm Gun M1.

UK MAGAZINE RETAILER BANS THE SALE OF SHOOTING MAGAZINES TO UNDER 14s

W H Smith, Britain's largest magazine retailer has banned the sale of shooting magazines to children under 14 years of age, on the grounds that they are too young to own a gun.

Shooting organizations are outraged, pointing out that there is in fact no lower age limit for obtaining a gun licence in the UK. They also point out that shooting is now encouraged in some schools where it is recognized that the sport helps develop self discipline and control in young people. Public interest in the sport of trap shooting has also been raised following Britain's success in the Olympic Games.

It was the refusal of large magazine retailers in the UK to stock gun magazines that brought about the demise of that wonderful magazine "Guns Review" following the Dunblane massacre. And what good has the handgun ban that also followed that tragic event done for public safety in the UK, where gang related shootings are now common events in the major cities.

This is just another example of how the anti gun fraternity are picking away at what we enjoy doing.

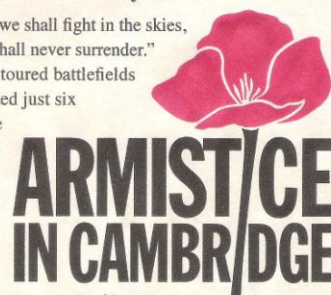

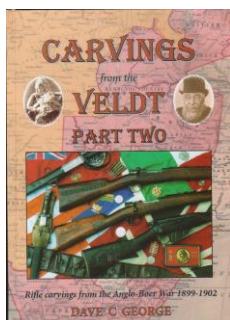

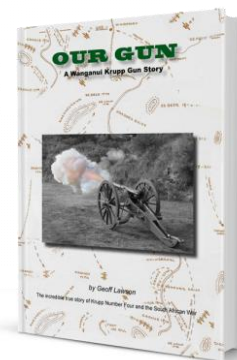

In a national sense, Krupp Number Four is “Our Gun”. It is New Zealand’s only 19th century Krupp, our only black powder Krupp and of course, our oldest Krupp. It is also our only surviving Boer War artillery gun and our first artillery gun trophy – in other words, it is an icon and a national military treasure. The story of Krupp Number Four is a good deal more than a story about a gun. It is a story about people and events in far-off Africa that had a profound influence on our political and military history. At the beginning of the 20th century, these events were at the forefront of public consciousness, just as the Vietnam War was in the sixties and the Iraq War was in the ninety’s.
